TIME LINE ALLAN IRVING (1945-)

- 1945 Born in Vancouver
- 1967 B.A. in Philosophy, York University (Toronto).
- 1967-1970 Social worker, Ontario. Ministry of Correctional Services.
- 1970-1972 **M.A. in Social Work, Carleton University (Ottawa)**. He received a governmental fellowship from the Ministry of Correctional Services of Ontario during his M.S.W.
- 1972-1973 Social worker consultant, Ontario. Ministry of Correctional Services.
- 1973-1976 Executive director, Big Brothers Association of Ottawa and District.
- 1977-1982 **Ph.D. in Social Work, University of Toronto.** Title of the thesis: *A Canadian Fabian: The Life and Work of Harry Cassidy*. During his doctoral studies, Allan Irving was lecturer in the Faculty in 1976 and 1977, and as instructor in 1980. He also received a fellowship from the Canadian Department of National Health and Welfare for his doctoral studies, from 1977 to 1980.
- 1980-1984 University of Western Ontario. King's College. Allan Irving was assistant professor at the Department of Social Work and taught the following undergraduate courses: *Introduction to Social Work and Social Welfare*, from 1980 to 1984 ; *The History of Canadian Social Welfare*, from 1982 to 1984; and *Canadian Social Policy*, from 1980 to 1984.
- 1984-2000 University of Toronto. Allan Irving was appointed assistant professor at the Faculty of Social Work (FSW) in 1984. He actively participated in the academic activities of the Faculty in teaching the following courses: Community Social Work Practice, in 1984 and 1985; Family Social Policy, in 1984 and 1985; Social Welfare and the Disadvantaged, from 1984 to 1986; Welfare Systems in Canada (course he designed), from 1984 to 1998 ; Historical Research in Canadian Social Welfare (course he designed), from 1984 to 1998; Social Welfare in Canadian Context (course he designed), from 1984 to 2000; History and Philosophy of Social Work and Social Welfare, from 1988 to 1998; Provincial Social Welfare Policy and Service Systems, in 1992; Social Welfare Policy and Service Systems, from 1992 to [1998]; Mental Health Issues and Social Policy, from 1992 to 1998; and Ph.D. reading courses from 1987 to 2000. Throughout the years at the FSW, he was involved in several doctoral committees and was supervisor of Ph.D. students. He also actively participated in the administrative activities of the Faculty by being part of several committees, such as: chairperson of the Faculty Council from 1986 to 1988; chairperson of the Teaching Faculty in 1988 and 1989; chair of the Ph.D. and M.S.W. Studies committees in 1989 and 1990 ; chair of the Teaching Effectiveness Committee in 1991 and 1992 and then member until 1995. Allan Irving was appointed dean of

student affairs in 1989 and 1990. He received the "Teacher of the Year Award for the academic years of 1989-1990, 1991-1992, 1993-1994, 1994-1995, and 1996-1997. He also received the award for "Teaching Excellence" for the academic year of 1991-1992.

Allan Irving was also actively involved in the academic and administrative activities of the University of Toronto by being part of various committees: member of the Settlement House's board of directors, in 1985 and 1986; member of the School of Graduate Studies' Graduate Faculty since 1988; member of the Harold Innis Foundation's board of directors from 1988 to 1992; member of the Academic Board of the University from 1991 to [1994?]; member of the Archives advisory committee on the University of Toronto Library Oral History program, from 1991 to 1995.

- 1985-1992 **St. Christopher Settlement House**. Member of the advisory committee on writing the history of the house.
- 1987-1992 Allan Irving was also involved in academic activities of other teaching institutions in social work. He taught the graduate course *Canadian Social Policy* at **Wilfrid Laurier University** from 1987 to 1990 and the undergraduate course *Study in social policy* in 1992. He also taught the undergraduate course *Law and Social Welfare* at **Nipissing University College** in 1989-1990 and at **Laurantian University** in 1994.
- 1988-1995 **University of Toronto. School of Graduate Studies** (SGS). Allan Irving became full member of the School of Graduate Studies in 1988. He also actively participated in the activities of the SGS in being part of the following committees: member of the council, the executive committee (division II) and the degree committee (division II) in 1989 and 1990 ; member of the School's committee to examine the SGS leave policy from 1989 to 1991. Irving was also involved in various committees and organizations on the University campus (see above).

- Since 1985 *Canadian Review of Social Policy*. He also participate actively in the administrative activities of the Center for Social Work: member of the Academic Affairs Committee since 1998 and chairperson since 1999 ; member of the Honors Advisory Committee since 1999 ; member of the Continuing Education Committee since 1999 ; member of the Diversity Committee from 1998 to 2000. Big Brothers Association of Ottawa and District: executive director from 1973 to 1976. Ottawa Rape Crisis Centre: founding member in 1975-1976. Ottawa-Carleton Citizens Advocacy: member of the board of directors from 1974 to 1976. University of Western Ontario. King's College: assistant professor at the Department of Social Work from 1980 to 1984. Wilfrid Laurier University: he taught graduate courses from 1987 to 1990 and in 1992. University of Toronto. Faculty of Social Work (FSW): assistant professor, from 1984 to 1987; associate professor with tenure, from 1984 to 2000; associate dean, student affairs in 1989 to 1991. Irving also participated in the administrative activities of the FSW as chairperson of the Faculty Council from 1986 to 1988; chairperson of the Teaching Faculty in 1988 and 1989; chair of the Ph.D and M.S.W. Studies committees in 1989 and 1990 and member from 1996 to 1998; member of the Ph.D Admission Committee from 1988 to 1990; chair of the Teaching Effectiveness Committee in 1991 and 1992, and member from 1992 to 1995; member of the Tenure committee in 1992; member of the Executive Committee from 1992 to 1995; member of the Committee to Rank Students for Fellowship and Awards from 1992 to 1998. and in 1996-1997 ; FSW's Award for Teaching Excellence in 1991-1992 ; nominated by the FSW for an Ontario Confederation of University Faculty Association (OCUFA) teaching award in 1993-1994 ; awarded the FSW's "Teacher who Most Represents Social Work Values" in 1997-1998 ; elected to membership in the Honor Society of Phi Kappa Phi, March 2000.

Scope and Content: The series documents Allan Irving's activities as a doctoral candidates at the University of Toronto's Faculty of Social Work, between 1976 and 1983 : his application and registration; the fellowship he received from the department of National Health and Welfare of Canada; lecturer position at the Faculty for Professor Albert Rose; doctoral seminars he attended, papers he prepared during his graduates years and academic results. The series also documents his membership with historical associations such as the Ontario Historical Society and the University of Tennessee's Social Welfare History Group. The series documents Allan Irving's applications for teaching positions in Canadian universities, from 1982 to 1994 ; his nomination for the Ontario Confederation of University Faculty Association's Teaching Award in 1994, nomination prepared by Marion Bogo, associate professor and acting dean of the University of Toronto's Faculty of Social Work, and Mary Lee. This series also partially documents Irving's friendship with professors and/or colleagues.

It also documents his exchanges with Faculty colleagues about teaching issues and with students ; his lecture given in the University of Toronto Department of Behavioral Science in 1994 ; his activities as instructor for the Massey lectures (School of Continuing Studies), during the fall term of 1996.

The series consists of 76 files including course outlines, bibliographies and course evaluations; lectures notes and working notes; student lists, assignments and grades; correspondence; articles and press clippings. It also includes sound recordings of interviews with Bessie Touzel regarding her years with the Toronto Welfare Council (1940-1948), by Linda Patton-Cowie on March 11 and 18, 1985 (B2000-0022/002S); sound recording of an interview with Reverend W. Robert Lacey, by Iris Anna Enkurs on April 4, 1986, regarding the period he was Chief Social Worker

The series also documents Irving's appointment to the position of chairperson during the Ontario Graduate Scholarship (OGS) selection panel; his appointment as member of the Board of directors of the Toronto Metropolitan Social Planning Council in 1990.
