BIOGRAPHICAL NOTE:

Dr. Clarence Bynold Farrar (1874-1970) contributed to the development of modern psychiatry in North America for nearly a half a century. From 1925 to 1947, Dr. Farrar served as director of the Toronto Psychiatric Hospital and professor and head of Psychiatry at the University of Toronto. In addition, he was editor of one of the world's leading psychiatric journals, *the American Journal of Psychiatry*, for 34 years.

Dr. Farrar was born in Cattaragus, New York, on November 27, 1874. He graduated from Cattaragus High School in 1891. He spent the next two years as an undergraduate at Allegheny College in Meadville, Pennsylvania before transferring to Harvard College. After receiving an A.B. from Harvard in 1896, Dr. Farrar entered John Hopkins Medical School. There, he studied under the giants of medicine - William Osler, William Welch, William Halstead, and Howard Kelly - and graduated with his M.D. in 1900.

Upon graduation from medical school, Dr. Farrar served two years of internship at the Sheppard and Enoch Pratt Hospital in Baltimore, Maryland. He then went to the University of Heidelberg for postgraduate training in psychiatry. From 1902 to 1904, Dr. Farrar worked under the supervision of several of the founders of modern psychiatry and neuropatholgy - Emil Kraepelin, Franz Nissl, and Aloys Alzheimer.

In 1904, Dr. Farrar returned to Sheppard and Enoch Pratt Hospital to become Assistant Physician and Director of Laboratories. At the same time, he was made Associate in Psychiatry at the Johns Hopkins Medical School. In 1913, Dr. Farrar moved to Trenton Hospital, New Jersey, where he took an appointment as Assistant Physician and Lecturer in Abnormal Psychology at Princeton University. Later, from 1916 to 1923, Dr. Farrar served as Chief Psychiatrist in the Department of Soldier's Civil Reestablishment in Ottawa.

In 1926, after a short period as Medical Director of Homewood Sanitarium in Guelph, Ontario, Dr. Farrar was appointed Medical Director of the Toronto Psychiatric Hospital and Professor and Head of the Department of Psychiatry at the University of Toronto. He remained in this position until his retirement in 1947. During his tenure, the Department of Psychiatry initiated the first Canadian graduate programme in psychiatry and the Toronto Psychiatric Hospital became the premier institute for training psychiatrists in English Canada.

Dr. Farrar's academic and clinical approach to psychiatry was undoubtedly influenced by his connections with *the American Journal of Psychiatry*. Between 1931 and 1965, he served as editor of the prestigious

journal. His stature as editor was such that, in 1957, a volume of *the American Journal of Psychiatry* was dedicated "to show Dr. Farrar as an eminent psychiatric scholar, an outstanding clinician and a wise and effective editor". ¹ Upon his retirement as Editor, Dr. Farrar was made Editor *emeritus*.

For his significant contributions to psychiatry, Dr. Farrar received many national and international honours. These include: a D.Sc. from McGill University in 1961; an L.L.D. from the University of Toronto in 1964; the Order of Service Medal from Canada in 1969; and the Thomas W. Salmon Committee Award from the New York Academy of Medicine in 1969.

Dr. Farrar married Evelyn Linwood Lewis of Alexandria, Virginia in 1911. The couple had two daughters, Evelyn Aida, born in 1914, and Clarice Elaine, born in 1918. Dr. Farrar later married Joan Gage in 1964. He died in his Toronto home at the age of 95, on June 3, 1970. In Dr. Farrar's memory, Dr. Aldwyn B. Stokes, his successor at TPH, wrote: "To all his friends, his colleagues and his students, his passing is grievous – they will mourn the man while remembering with gratitude, his good works and his great influence on the psychiatry of his era."²

SCOPE AND CONTENT:

This fonds consists of the personal and professional papers of Dr. Clarence B. Farrar. These records broadly document all aspects of Dr. Farrar's long life - from his childhood in Cattaragus, New York during the 1870's to his active retirement in Toronto during the 1960's. Most of the records concern Dr. Farrar's professional activities at Sheppard Enoch Pratt Hospital, New Jersey State Asylum, the Department of Soldier's Civil Re-establishment, the Homewood Sanatorium, Toronto Psychiatric Hospital and the U. of T. Department of Psychiatry. Types of professional records include: administrative correspondence; research notes; lecture notes; patient files; brain slides; and photographs. Further, this fonds also contains Dr. Farrar's correspondence with the greatest doctors and psychiatrists of his time - William Osler, Franz Nissl, Emil Kraepelin, C.K. Clark, and Edward N. Brush. This fonds also includes Dr. Farrar's personal records such as photographs of and correspondence with family members and colleagues.

However, in addition, to documenting Dr. Farrar's life, these records are also significant because they shed light on the history of Canadian psychiatry. Little is known about psychiatric teaching and clinical practice in the first half of the twentieth century. Dr. Farrar's records therefore provide a much needed commentary on this period. Indeed, Dr. Edward Shorter, the Hannah Chair in the History of Medicine at the University of Toronto, writes: "Through Farrar's long career in North American run some of the fundamental themes of psychiatry and the history of psychiatry ... He participated intimately in these events and left us a full record."

Custodial History:

Dr. Farrar's records were physically transferred to the University Archives in 1998 and 1999. The majority of these records came from Mrs. Farrar's home in Toronto. Further, between 1994 and 1999, other parts of Dr. Farrar's fonds were stored, arranged, and made publicly accessible at the History of Canadian Psychiatry and Mental Health Archives. These records were later transferred to the University of Toronto Archives in April 1999. As a consequence of their complicated custodial history, the original order of Dr. Farrar's records has been lost.

SERIES DESCRIPTIONS

SERIES I. Personal Life and Family

1865-1990, predominant 1890-1960, [multi-media], 2 m.

This series documents Dr. Farrar's family and personal life from the 1870's to the 1970's. The records in this series have been divided into 2 sub-series and are described below.

Sub-series I. Textual

Sub-series I consists of the textual records pertaining to Dr. Farrar's family and personal life from 1881 to 1970. The records consists mainly of correspondence to and from Dr. Farrar's mother, Marie Farrar, his father, Thomas Jefferson Farrar, his first wife, Evelyn Lewis Farrar, and their daughters, Evelyn and Clarice. In addition, the records also document his friends, early life and high school education in Cattaraugus, New York. Types of records include: invitations and cards; marriage certificates; passports; personal business correspondence; correspondence with Cattaraugus friends; and high school course notes. Also included are Dr. Farrar's personal writings such as a diary, a travel diary, and short stories.

Sub-series II. Photographs

Photographs in this sub-series document Farrar's extended family in Cattaraugus and New York state from about the 1870s to the early 1900s. There is a large collection of nineteenth century Carte de Visites and Portrait Cards of his parents, T.J. Farrar and Marie Farrar, and their relatives. Some are identified while others are not. Also among these photographs are images of the various Farrar homes in Cattaraugus, views of group outings such as picnics and parties ca. 1890s, as well as general views of Cattaraugus. Also found among these older photographs are three photographs of skeletons or skulls. The photographer of these experimental type images is unknown but is most probably a member of the Farrar family or C.B. Farrar himself. These photographs are grouped and arranged according to subject as outlined above.

This sub-series also includes photographs of Dr. Farrar's immediate family, mainly his children, Evelyn and Clarice, and his first wife, Evelyn, before 1940. There are also two photographs of Joan Farrar, his second wife. There are numerous professional portraits and extensive snapshots documenting his early life with Evelyn, his various domiciles and the girls' childhood. Also included in this series are portraits of Farrar from his early childhood up to around the 1950s. Included are portraits by Milne Studio of Toronto, Frederick William Lyonde and Sons of Toronto, and a reproduction of a painting of Dr. Farrar by artist, Archie Barns. Formal portraits are filed by person at the beginning while snapshots are filed afterwards and are grouped by subject and roughly sorted by date.

SERIES II. College Education

1880-1959, predominant 1891-1902, [multi-media], .25 m.

After graduating from Cattaragus High School in 1891, Dr. Farrar spent two years as an undergraduate at Allegheny College in Meadville, Pennsylvania. He then transferred to Harvard College where he enjoyed courses with famous professors such as the philosopher, George Santayana, and the psychologist, James Welch. Dr. Farrar received his A.B. in 1896. He then spent the next year at Harvard Medical School before transferring to the Faculty of Medicine at Johns Hopkins University in Baltimore, Maryland. There, he studied under the 'four horsemen' of Johns Hopkins medicine - William Osler, William Welch, William Halstead, and Howard Kelly - and graduated with his M.D. in 1900.

The records in this series document Dr. Farrar's undergraduate arts and graduate medical education at Allegheny College, Harvard College, and John Hopkins University. The records deal mostly with Dr. Farrar's classroom activities, rather than his social life. The records have been divided into four subseries and are described below.

Sub-series I. Allegheny College

Sub-series consists of course notes and Allegheny College orders, 1880-1893.

Sub-series II. Harvard

Records in this sub-series document Dr. Farrar's student days at Harvard College, 1893-1898. Records consist of course notes, exams and a certificate. Also included are programmes, invitations and correspondence from his fellow alumni.

Sub-series III. Johns Hopkins

Sub-series pertains Dr. Farrar's student activities at the Faculty of Medicine of John Hopkins University, 1898-1900. Records include lecture notes, exams, a certificate and alumni notices.

Sub-series IV. Photographs

Photographs include views of classmates at Allegheny College and Harvard University, fraternity and sorority group photos as well as one large composite of Harvard Students in which Dr. Farrar appears in the 5th row from the top, 12th from the right (/007P (02)).

SERIES III. Professional Correspondence

[1897?]-1970, [textual], 1 m.

Throughout his long career, Dr. Farrar had contact with the world's leading physicians and psychiatrists. The records in this series document these professional connections. Records include letters from Sir William Osler, Sir David Henderson and Franz Nissl. Also included is correspondence from Dr. Farrar's colleagues on the <u>American Journal of Psychiatry</u> such as Edward Brush, G. Alder Blumer, Henry M. Hurd and Charles Macfie Campbell. Canadian correspondents include Dr. C. K. Clark, Clarence Hincks, and Robert Noble.

SERIES IV. Sheppard and Enoch Pratt Hospital and Johns Hopkins Medical School 1897-1951, predominant 1900-1913, [multi-media], .5 m.

Between 1900 and 1902, Dr. Farrar completed an internship at Sheppard and Enoch Pratt Hospital in Maryland. Then, after post-graduate training in Europe, he returned to the Hospital in 1904 to become Assistant Physician and Director of Laboratories. At the same time, he was also made Associate Professor in Psychiatry at the Johns Hopkins Medical School. He remained in these joint positions until 1913.

This series documents Dr. Farrar's activities at Sheppard and Enoch Pratt Hospital and Johns Hopkins Medical School. The records have been divided into three sub-series to reflect Dr. Farrar's administrative, teaching and clinical functions. An additional fourth series consists of photographs.

Sub-series I. Administrative

Sub-series contains administrative records created and received by Dr. Farrar while at Sheppard and Enoch Pratt Hospital. Records consist of professional correspondence with various colleagues such as Stewart Paton and Edward Brush as well as reports.

Sub-series II. Clinical

Sub-series consists of clinical records kept by Dr. Farrar including patient files, patients' correspondence, patients' notebooks and clinical forms.

Sub-series III. Teaching

Sub-series includes notes on classical history and a programme of Dr. Farrar's lectures.

Sub-series IV. Photographs

Photographs include group images of nursing and medical staff as well views of Farrar's apartment and office in Baltimore. There are also graphic photographs of a cadaver, possibly used for teaching.

SERIES V. Heidelberg

1902-1951, predominant 1902-1904, [multi-media], 1.25 m.

Between October 1902 and May 1904, Dr. Farrar took leave from Sheppard and Enoch Pratt Hospital for post graduate medical training in Europe. Although he traveled widely, attending lectures and meeting scientists in Munich, Paris and London, Dr. Farrar spent most of his time at Emil Kraepelin's psychiatric clinic in Heidelberg. There, Dr. Kraepelin had revolutionized modern psychiatric diagnosis. Kraepelin, along with his Heidelberg colleagues, Franz Nissl and Aloys Alzheimer, rejected the nineteenth century practice of reducing mental illness to brain disease. Instead, the Heidelberg School emphasized careful description and clear understanding of individual symptoms in psychiatric diagnosis. When Dr. Farrar returned from Heidleberg in 1904, he had received thorough training in Kraepelin's psychological approach. He also returned mindful of the Heidelberg School's emphasis upon brain histopathology, neurohistology, and neuropathology.

The records in this series pertain to Dr. Farrar's personal and professional activities in Heidelberg. Records consist of a personal diary, research notes and patient observations. Also included is personal

correspondence from various Heidelberg colleagues such as Franz Nissl, Emil Kraepelin, Albert Deveaux, and Charles Macfie Campbell. Photographs include mainly snapshots taken by Farrar of the German towns and countryside, of his colleagues at Heidelberg, and of the university and his personal study.

In addition, this series also contains glass slides, printing plates, a gravity measuring device, and a knife for preparing brain tissues for slides. During his Heidelberg studies, Dr. Farrar, along with Franz Nissl and Aloys Alzheimer, became occupied with the microscopic study of brain disease. Dr. Farrar prepared these slides under Dr. Nissl's supervision.

SERIES VI. New Jersey State Asylum and Princeton University

1900-1917, [multi-media], .25 m.

In 1913, Dr. Farrar took an appointment as 3rd Assistant Physician at the New Jersey State Asylum, in Trenton, New Jersey and as a Lecturer in Abnormal Psychology at Princeton University. The records in this series were created in Dr. Farrar's capacity as physician and lecturer in 1913 to 1916. This series has been divided into the following three sub-series to reflect Dr. Farrar's administrative, clinical and teaching activities at Trenton. Photographs documenting his time at Trenton constitute a fourth subseries.

Sub-series I. Administrative

Sub-series pertains to Dr. Farrar's administrative responsibilities at the New Jersey State Hospital and includes correspondence and reports.

Sub-series II. Clinical

Sub-series consists of clinical records created by Dr. Farrar as a physician at New Jersey State Asylum such as patient files and correspondence.

Sub-series III. Teaching

Records include Dr. Farrar's research notes and lectures delivered to Princeton University students.

Sub-series IV. Photographs

Snapshots document the staff at Trenton Hospital, and includes images of Farrar with his first wife, Evelyn. There are two formal photographs of staff, one of which was taken at Dr. Felty's Farewell Dinner in 1915. Names of the individuals are identified on the back of the photo. There are also two rolled photographs showing a graduation ceremony for nurses which could possibly have been at Trenton.

SERIES VII. Department of Soldier's Civil Re-establishment

1905 – [194-], predominant 1916-1923, [multi-media], 1 m.

This series documents Dr. Farrar's work with the Canadian Federal Department of Soldier's Civil Reestablishment. In 1916, Dr. Farrar joined the Canadian army. Initially posted to a hospital unit in Kingston, Ontario, he was transferred to Ottawa for duty in the Military Hospitals Commission. Dr. Farrar would eventually become Chief Psychiatrist in the Federal Department of Soldier's Civil Reestablishment. In this capacity, he treated invalided soldiers suffering from psychiatric illnesses including shell shock. Though primarily based in Ottawa during the war, Dr. Farrar also worked out of the military hospital in Cobourg, Ontario, a photograph of which can be found in /003P(11). Records in this series consist of professional correspondence, reports, patient files, plans for a military hospital. There are also lantern slides depicting hospitals and asylums throughout North America in the early 1900s. It is believed that Dr. Farrar may have collected and used these images in his capacity as Chief Psychiatrist to put forth a proposal for a new military hospital.

SERIES VIII. Homewood Sanatorium

1909-1937, predominant 1923-1926, [multi-media], .25 m.

In 1923, Dr. Farrar left the Department of Soldier's Civil Re-Establishment to become Medical Director of Homewood Sanatorium, a private asylum in Guelph, Ontario. The records in this series were created in Dr. Farrar's capacity as head of Homewood and include colleagues' professional correspondence, patients' intercepted outgoing correspondence, patient case files and promotional flyers. Series also includes images of nursing staff at Homewood, 1923-25.

SERIES IX. Toronto Psychiatric Hospital and University of Toronto Department of Psychiatry 1905-1969, predominant 1925-1947, [textual], 1.5 m

In 1926, Dr. C.K. Clark recruited Dr. Farrar as medical director of the newly built Toronto Psychiatric Hospital and as head of the Department of Psychiatry at the University of Toronto. Dr. Farrar remained in these positions until his retirement in 1947. Between 1926 and 1947, Canadian psychiatry became a major center in international scientific circles. Indeed, under Dr. Farrar's tenure, the Toronto Psychiatric Hospital became a university teaching hospital and developed a clinical service for teaching and research. Further, in 1932, Dr. Farrar initiated the first Canadian postgraduate program for physicians in psychiatry. The program was broadly based and was accepted by the University as leading to a Diploma in Psychiatry.

Records in this series document Dr. Farrar's career at the Toronto Psychiatric Hospital and the University of Toronto Department of Psychiatry. This series has been divided into three sub-series to reflect the administrative, clinical, and teaching activities of Dr. Farrar's joint appointment.

Sub-series I. Administrative

Sub-series pertains to Dr. Farrar's administrative duties as medical director of the Toronto Psychiatric Hospital and as head of the Department of Psychiatry at the University of Toronto. Records include:

newspaper clippings, provincial resolutions, and reports. Also included is correspondence concerning the establishment of T.P.H., staff appointments, nursing and general administrative matters. In addition, this series contains small pencil sketches drawn by Dr. Frederick Banting during the opening of the new psychiatric clinic in the Hospital for Sick Children, January 1937. The sketches are of Drs. Bott, Kanner, Parsons, Primrose and Cody. These sketches can be found among the photographs in Box /003P (13).

Sub-series II. Clinical

Sub-series consists of Dr. Farrar's clinical records including patient files and correspondence.

Sub-series III. Teaching

At the University of Toronto, Dr. Farrar developed a reputation for being a dedicated teacher and mentor. In the book, <u>TPH History and Memories of the Toronto Psychiatric Hospital</u>, 1925-1966, one of Dr. Farrar's students during the 1920's, Dr. W. Clifford Scott, wrote: "During the 18 months I was at TPH, Farrar's lectures were given there and I skipped some of my other classes to hear him." Records in this sub-series document Dr. Farrar's teaching activities in the U. of T. Department of Psychiatry and include lecture and research notes.

SERIES X. Associations

1929-1969, [multi-media], 1 m.

Until his death in 1970, Dr. Farrar was an active member of various professional associations. These include: the American Psychiatric Association, the Canadian Psychiatric Association, the Academy of Medicine and the National Committee for Mental Hygiene. Further, Dr. Farrar had a great interest in medical history and participated in the Medical Historical Club of Toronto, the Osler Society, and the Cattaragus Historical Society. He was also a 32° Mason in the Scottish Rite. This series documents Dr. Farrar's participation in these associations. Records include conference programs, speeches, and correspondence. Also included in this series are photographs of Dr. Farrar as well as group photographs of participants at APA annual meetings.

SERIES XI. Research and Publications

1902-1975, [textual], 2 m.

In addition to editing the *American Journal of Psychiatry*, Dr. Farrar was also on the editorial boards of J.K. Hall, ed. <u>American Psychiatry (1844-1944)</u> (New York Columbia University Press, 1944), <u>Funk and Wagnall's New Encyclopedia</u> (New York: Funk and Wagnall, 1932), and <u>the Yearbook of Neurology and Psychiatry</u> (Chicago: Year Book Publishers, 1907). Further, although he never wrote a book, Dr. Farrar wrote 77 articles. 29 appeared in *the American Journal of Psychiatry* and 48 were printed in other journals and periodicals. He also wrote 273 book reviews for the AJP between 1908 and 1965.

The records in this series pertain to Dr. Farrar's various research and publication activities. This series, however, does not document Dr. Farrar's editorial work with the *American Journal of Psychiatry*. Series records include correspondence with authors, editors, and research foundations. Series also consists of research notes, subject files on various topics, and bibliographic card indices. Also included are manuscripts by Adolf Meyer and Jack Hannah. In addition, this series also contains artifacts Dr.

Farrar used in his research such as glass slides, printing plates, a gravity measuring device, and a knife for preparing brain tissues for slides.

SERIES XII. Awards and Honours

1923-1990, [multi-media], 1 m.

For his contributions to psychiatry, Dr. Farrar received numerous awards. In 1961, at the third world congress of psychiatry in Montreal, he was granted an honorary doctorate for his life's work in psychiatry and for his contributions to the *American Journal of Psychiatry*. The next year, at the annual meeting of the American Psychiatric Association in Toronto, he was presented with an editorial chair and in 1965, the *AJP* designated him Editor *emeritus*. In addition, the University of Toronto conferred on him an honorary doctor of laws degree. In 1969, the Governor General of Canada granted him the medal of service of the Order of Canada. Dr. Farrar also received the distinguished service award of the Thomas W. Salmon Committee on Psychiatry and Mental Hygiene. This series pertains to Dr. Farrar's various honours and includes correspondence, honorary certificates. Series also includes photographs of his investiture to the Order of Canada in 1969, his attendance at the opening of Clark Institute in 1965, as well as a photograph of an unidentified group in front of the White House, 193-.

SERIES XIII Portrait Collection

ca. 1920-1970, [graphic], 1.21 m.

This series is Farrar's collection of photographs of colleagues and historical medical and scientific personalities. Some photographs are originals and were autographed for Dr. Farrar. Others are reproductions of printed images or paintings. Many of these images would have been displayed in his office and home study. A few notable include Canadian doctors Frederick Banting and William Osler, colleague J.G. FitzGerald and Mary Jackson, Farrar's mentor C.K. Clarke, American colleagues Edward Brush, Lewellis Barker and famous European psychiatrists such as Adolf Meyer, Emil Kraeplin and Franz Nissl. There is a detailed list to this series.
