Biographical Sketch

Ernest Mastromatteo was a Canadian occupational physician born in Toronto, Ontario on December 16, 1923. His work includes research into threshold limit values of hazardous workplace materials including extensive research on health hazards associated with nickel mining and processing. He has also done much research and advocacy on broader issues of occupational health including the physiological effects of exposure to other chemical and mechanical hazards such as dust, fumes, and noise, ethical issues around health surveillance of workers and the human rights of workers as they relate to a safe workplace.

Dr. Mastromatteo graduated from Bloor Collegiate Institute in 1940 and was admitted to the Faculty of Medicine at the University of Toronto in 1942. He graduated with an MD in 1947. Dr. Mastromatteo also received a Diploma in Public Health in 1950, and a Diploma in Industrial Health in 1958, both from the University of Toronto. In 1958 Dr. Mastromatteo earned Certification in Occupational Medicine (FABPM) from the American Board of Preventative Medicine by Examination, and in 1981, he earned Certification in Occupational Medicine (CCBOM) from the Canadian Board of Preventative Medicine by Examination. In 1982, Dr. Mastromatteo became a Member through distinction of Faculty of Occupational Medicine, London.

Following his graduation from the University of Toronto in 1947, Dr. Mastromatteo did his Junior Internship at St. Michael's Hospital in Toronto from 1947-1948 and his Senior Internship in Medicine at Ottawa General Hospital. In 1949, he became Medical Director of Virden Local Health Unit in Virden, Manitoba. In 1952, Dr. Mastromatteo joined the Ontario Ministry of Health, where he was appointed director in 1968. Between 1966 and 1974, Dr. Mastromatteo was also a Consultant on Occupational Diseases for the Ontario Workers' Compensation Board and a Professor at the School of Hygiene at the University of Toronto in addition to his role at the Ministry of Health.

In 1974, Dr. Mastromatteo left his three roles in Canada to work as the Chief of the Occupational Health and Safety Branch of the International Labour Office in Geneva, Switzerland. In 1976, he returned to Canada to begin working as the Director of Occupational Health for INCO Limited, a mining company. From 1976 to 1997, Dr. Mastromatteo also served as an honorary consultant for the Occupational Health Clinic at St. Michael's Hospital in Toronto. In 1985, Dr. Mastromatteo left his position at INCO to work as a consultant for the Occupational Health and Safety Branch of the Ontario Workers' Compensation Board until 1990. Between 1984 and 1994 Dr. Mastromatteo was the Program Director for Organization Resources Counselors Canada Inc. in Toronto. In 1987, Dr. Mastromatteo was appointed Professor Emeritus of Occupational and Environmental Medicine at the University of Toronto. Dr. Mastromatteo never formally retired and continued to do consulting work after leaving ORC Inc.

Dr. Mastromatteo was very active in a number of professional associations throughout his career, most notably the American Conference of Governmental Industrial Hygienists, where he was president from 1969-1970, and Chair of the TLV (Threshold Limit Value) Committee from 1985-1990. Dr. Mastromatteo was also a member of the Canadian Medical Association, the Ontario Medical Association, where he chaired both the Section on Occupational Health and the Committee on Public Health, and he was a member of the Ontario Thoracic Society where he was President

from 1966-1968. Dr. Mastromatteo was also a member of the Ramazzini Medical Society and the International Commission on Occupational Health among others.

Dr. Mastromatteo received many honours and awards throughout his career. In 1979, he won the Canada Safety Council Achievement Award for Occupational Health and Safety in Canada and in 1981, he won the Stokinger Award for Scientific Contributions to Occupational Toxicology in the United States. Dr. Mastromatteo was appointed to the ILO (International Labour Office) Panel on Occupational Carcinogens in 1981. In 1986, Dr. Mastromatteo was given the Yant Award for Scientific Contributions to Industrial Hygiene in the United States and was also elected Member of the Faculty of Occupational Medicine at the Royal College of Physicians in London. In 1987, Dr. Mastromatteo was inducted into the Safety and Health Hall of Fame International and won the Knudsen Award for contributions to occupational medicine in the United States. In 1990, Dr. Mastromatteo was granted lifetime memberships in the Ontario Medical Association, Canadian Medical Association, American Conference of Governmental Industrial Hygienists and the American Industrial Hygiene Association. In 1999, Dr. Mastromatteo received the Lifetime Achievement Award for Occupational Health in Canada.

Dr. Mastromatteo was the author of 45 publications on occupational health, toxicology and environmental health, as well as the author of four book chapters and a member of the editorial committees for two books.

Dr. Mastromatteo died on July 13, 2016.

This fonds contains records related to the professional activities and personal life of Dr. Ernest Mastromatteo, occupational physician. The bulk of the material in this fonds documents his roles as a medical practitioner, researcher, and occupational health director. The series documenting the activities of the Nickel Producers' Environmental Research Association, an association Dr. Mastromatteo was heavily involved in during the 1980s, is the largest, with smaller series documenting his career at Inco, his work with the American Conference of Governmental and Industrial Hygienists, and his many projects, case studies, organizations, associations and societies, as well as legal cases he provided testimony in. There is also a relatively large amount of material documenting his research in the form of addresses, and additional material chronicling his time as a student at both the University of Toronto Faculty of Medicine and the School of Hygiene.

Records include correspondence, notebooks, publications, drafts, prints, reports, meeting minutes and memoranda.

Arrangement Note: The arrangement of this fonds is based on the order in which it was received by the University. Before this fonds was donated, it was already partially sorted and arranged by a group of contemporary scientists and occupational physicians. The degree to which this first arrangement adhered to Dr. Mastromatteo's original order is difficult to discern. Comments written by the first arrangers on original folders have been retained within files.

This series consists of Dr. Mastromatteo's biographical and personal records. They document his career, personal life, and professional and personal relationships. This series also contains many files documenting studies, projects and issues that Dr. Mastromatteo included with his personal files. Record types include curriculum vitae, correspondence, photos, cards and certificates, articles, pamphlets, reports, notes, forms, minutes and projector slides.

The material is arranged into two sections. The first section contains personal records, career records, records documenting relationships, education records, and general files. The records are arranged in that order and filed chronologically within each of those sub-sections. The second section contains files on specific work projects or issues and is arranged chronologically.

This series documents Dr. Mastromatteo's time as a student at the University of Toronto Faculty of Medicine (1942-1947), and later the School of Hygiene (1949-1950). The records pertain mainly to his education but also to more general life events and rites of passage. There is also one file of material from his time as a faculty member at the School of Hygiene, and some material from the Faculty of Medicine class of 1947 alumni. As he attended the Faculty of Medicine during World War II, the medical program was compressed from 6 to 4 years, and holidays were eliminated and replaced with army basic training. After the war ended, the program transitioned back to its normal schedule. For this reason, the class notes in B2018-0034 are somewhat irregularly dated. The Class of 1947 reunion "Then and Now" document contains a more detailed description of the medical program during and after the war.

Records in this series include a scrapbook, class notes, and a small amount of correspondence and press clippings.

The material in B2015-0006 is arranged chronologically with the scrapbook at the beginning and one file of unidentified materials at the end. The class notes in B2018-0034 are arranged alphabetically by subject.

The addresses in this series are mainly about occupational health, with some on environmental issues and human rights issues as they relate to occupational health (for example workers' compensation). Most addresses in this series were given at meetings of professional associations with a small number of talks given at private companies.

Records in this series include notes, manuscripts, correspondence, projector slides, reports and press clippings.

The material in this series is arranged chronologically with addresses of unknown dates filed at the front of the decade they most likely belong to. Miscellaneous files, correspondence files and press clippings are filed at the end, along with some reference material.
