BIOGRAPHY

Margaret O'Gara (1947-2012) was a regular member of the Faculty of Theology, University of St. Michael's College, from 1976 to 2012. She obtained her B.A. in English and Philosophy at Trinity College in Washington, DC in 1969, followed by her M.A.R. in Theology at Yale Divinity School in 1971. She completed her Ph.D. in Theology at USMC in 1980 and was promoted to Assistant Professor. She became Associate Professor in 1985, Professor in 1998, and Sisters of St. Joseph of Toronto Chair in Systematic Theology in 2007.

O'Gara's theological specialty was ecumenical theology, the personally engaged study of the divisions between the Christian churches for the sake of overcoming them. Besides her teaching, research, writing, and extensive public lecturing, she served on five official national or international dialogues between the Roman Catholic Church and other churches: the Anglican-Roman Catholic Dialogue of Canada (1976-93); the Disciples of Christ-Roman Catholic International Commission for Dialogue (1983-2012); the U.S. Lutheran-Roman Catholic Dialogue (1994-2012); the Lutheran-Roman Catholic International Commission for Unity (1995-2007); and the Evangelical-Roman Catholic Dialogue of Canada (2008-2012). She was a member of Bridgefolk, a North American organization for dialogue between Roman Catholics and Mennonites (2002-2012). She served as president of the North American Academy of Ecumenists (1987-89) and the Catholic Theological Society of America (2007-2008). She was a member of the Toronto Archdiocesan Ecumenical Commission (1988-2012). She was a board member of the Collegetown Institute for Ecumenical and Cultural Research (1990-2012). She served as the anglophone theological advisor to the delegation from the Canadian Conference of Catholic Bishops at the World Synod of Bishops (2001). And she was chair of the Theology Department, Toronto School of Theology (2003-2005).

Besides roughly 80 articles, O'Gara published three books: *Triumph in Defeat: Infallibility, Vatican I, and the French Minority Bishops* (Catholic University of America Press, 1988), *The Ecumenical Gift Exchange* (Liturgical Press, 1998) and *No Turning Back: the Future of Ecumenism* (Liturgical Press, 2014).

SCOPE OF FONDS

This fonds consists of teaching material, correspondence (professional and personal), and materials related to Professor Margaret O’Gara’s professional activities, organizational work, and various appointments. Because these fonds are organized by received order, each file has also been assigned to a material type category to provide users with a thematic overview of files.

The material types and their scope are:

- **Course materials:** Materials related to courses that O’Gara taught. Many course files contain multiple syllabi and materials from different semesters from over the course of O’Gara’s teaching. Materials may contain course syllabi, handouts (reference material, style guides), lecture or tutorial notes, bibliographies, exam or test materials, course planning material, correspondence about courses, course evaluations, and some student work.
- **Service materials:** Materials related to church services. This includes service schedules, handouts, pamphlets, hymns, sheet music, and printed or written prayers.
- **News articles:** Articles that have been cut out or photocopied from newspapers or magazine as well as articles printed from the internet. This is sometimes part of other categories, and is most often related to the other material in the file.
- **Correspondence:** Includes professional or personal correspondence. These may be in the form of written letters, postcards, or greeting cards. This also includes references or recommendations O’Gara wrote on behalf of students and colleagues.
- **Faculty materials:** Materials related to USMC’s Faculty of Theology. This includes internal correspondence, memos, meeting minutes, faculty reports and reviews, and materials related to committees and councils that O’Gara was involved in. It also includes material related to examinations, dissertations, and thesis work as well as documents related to disputed grades.
- **University Material:** Materials concerning University of Toronto or USMC. This includes internal correspondence, memos, meeting minutes, university reports and reviews, and materials related to committees and councils that O’Gara was involved in, as well as UofT-USMC relations.
- **TST material:** Materials related to the Toronto School of Theology. This includes reports, directories, meeting minutes, correspondence, resumes, surveys, and materials related to committees and councils that O’Gara was involved in. It also includes materials related to O’Gara’s seat on the Board of Trustees and Executive Board.
- **Misc. Interfaith Work:** Includes materials related to groups, reports, task-forces, committees and commissions that O’Gara was involved in.
- **O’Gara Published Work:** Includes academic papers, essays, and chapters that O’Gara wrote or edited.
- **CTSA Material:** Materials related to O’Gara’s involvement with the [Catholic Theological Society of America](#). This includes meeting agendas and minutes, correspondence and memos, directories, and public/published statements. Also includes materials related to committees, councils, conventions, and workshops that O’Gara was involved in as part of her CTSA work.
- **IECR material:** Materials related to O’Gara’s involvement with the [Institute for Ecumenical and Cultural Research](#). This includes meeting agendas and minutes, correspondence and memos, public/published statements. Also includes materials related to committees, councils, and consultations that O’Gara was involved in as part of her IECR work.
- **NAAE:** Materials related to O’Gara’s involvement with the [North American Academy of Ecumenists](#). This includes meeting agendas and minutes, correspondence and memos, directories, and materials related to conference planning. Also includes materials related to committees, councils, and consultations that O’Gara was involved in as part of her NAAE work.

- **ARC-Can:** Materials related to O’Gara’s Anglican-Roman Catholic Archival project. This includes some correspondence, meeting notes, and research and reference material. Many of these files are the ARC-Can documents themselves and include indexes of documents inside the file. Material also includes agreed statements and papers published by ARC-Can.
- **ARCIC material:** Materials related to O’Gara’s involvement with the Anglican-Roman Catholic International Commission. This includes meeting agendas and minutes, correspondence and memos, and directories. Also includes drafts and published statements and ARCIC responses to various organizational responses to the ARCIC report.
- **DRC work:** Materials related to O’Gara’s involvement in several Disciples of Christ Roman Catholic International Commissions. This includes member directories, meeting agendas and minutes, correspondence and memos, and directories. Also includes conference planning, as well as drafts and published agreed statements and accounts, reports, and papers.
- **LRC Commission:** Materials related to O’Gara’s involvement in the Lutheran Roman Catholic Commission. This includes member directories, correspondence, research, travel documents, organizational ephemera, meeting agendas and notes. Also includes drafts of LRC statements, chapters, papers, reports, responses. Some material is in German.
- **Misc. Conferences:** Includes materials related to conferences, seminars, and symposiums that O’Gara attended, spoke at, or organized. These include:
