EARLY RECORDS

Officials at the Institute, 1929-1939

The Institute was developed in its early years as a graduate faculty at St. Michael's College. The Superior of the College in 1929 was Father McCorkell. In August 1931 Father Henry Bellisle became Superior, and held that office until 1934 when Father McCorkell took over again until 1940. From 1935/36 the Institute presented itself as independent of St. Michael's (in order, according to Father Scollard, to strengthen its case for its own pontifical charter). The Superior of St. Michael's still sat on the Council *ex officio*, as did the Basilian Superior General. The Basilians at the Institute became a *domus formata* on their own in 1942.

Father Henry Carr was the first President of the Institute in 1929, and retained that office even after becoming Superior General in 1930 (continuing to live where he had been living, in the Curial residence at 21 St. Mary St.) No President is listed in the Institute Catalogues for 1935/36 and 1936/37; according to Father Shook's *Catholic post-secondary education in English speaking Canada*, Father Gerald Phelan became Acting President in 1935. In 1936 the Statutes of the Institute were approved by Rome *ad experimentum*, and Archbishop McGuigan, *ex officio* Chancellor, nominated Father Phelan as President. The appointment was ratified in 1937, and Phelan remained President until 1946.

Etienne Gilson was Director of the Institute from the beginning. The catalogues from 1932/33 to 1936/37 list both Gilson and Phelan as Directors of the Institute. After that Phelan is listed as President, and Gilson as Director of Studies.

Father Phelan was Librarian of the Institute for its first three years, from 1929 to 1932. Father Robert Scollard, "Assistant Librarian" in 1931/32 (and ordained to the priesthood Dec. 21, 1932), became Librarian in 1932 (and held that office until 1951).

Father Bellisle was Secretary of the Institute for the first two years. During Father Bellisle's three years as Superior of St. Michael's, 1931 to 1934, Father McCorkell is listed in the Catalogue as Secretary. (He lived at 314 Tweedsmuir in Holy Rosary Parish as Master of Novices during these years.) Father V.L. Kennedy was Secretary from 1935 to 1944 (when he was succeeded by Father G. B. Flahiff.)

On looking at Bellisle's file as President of S.M.C. I noticed a number of items relevant to the Institute, and copied the 1931 items for inclusion here as a sample. (Note further Denomy letters in that file.) Bellisle, incidentally, was answering the Superior's mail as "Secretary" in May 1931, with Fr. McCorkell "away", and as "Acting Superior" on July 31, 1931. A letter to him dated Aug. 22, 1931, refers to the morning paper news of his appointment as Superior. He continued in that capacity until August 1934.

Father Henry Carr was the first President of the Institute in 1929, and retained that office even after becoming Superior General in 1930 (continuing to live where he had been living, in the Curial residence at 21 St. Mary St.) No President is listed in the Institute Catalogues for 1935/36 and 1936/37; according to Father Shook's Catholic post-secondary education in English speaking Canada, Father Gerald Phelan became Acting President in 1935. In 1936 the Statutes of the Institute were approved by Rome ad experimentum, and Archbishop McGuigan, ex officio Chancellor, nominated Father Phelan as President. The appointment was ratified in 1937, and Phelan remained President until 1946.

Diary of Trip to Rome in 1934

171pp, typewritten, double spaced, on paper 8 1/2" x 11", in a black ring binder. Most of this is a carbon copy, except for the last two pages, described as "Supplementary". A preliminary page lists "Abbreviations" of names mentioned throughout the Diary.

Another version of the first part of this diary (pp.1-29; the last day recorded is April 7, 1934) may be found in the SMC Carr file (Box [5]). This consists of 51 leaves, 140x212mm, typewritten, tied with string through two punched holes. The first two leaves consist of an itinerary indicating dates and places visited, which I have copied and inserted at the beginning of the Diary in the PIMS file.

It is my understanding that four copies of the Diary were typed by Father Carr's secretary at the time: one went to him, the other three to Fr McCorkell, father Flahiff, and to Father Carr's sister, Mrs Hatch. I think that the copy we have, which came to the Archives with other material from PIMS in the late summer of 1990, is the one that was given to Mrs Hatch.

The opening sentence of this letter says "It is some time since I saw in the paper that you are retiring...", whereas Bellisle would have known about DeLury's retirement from a letter of Dec.4, 1933 from A.B.Fennell, Secretary of the Faculty of Arts. It would be interesting if the letter were from Bellisle, since it is so full of "the spirit animating the University" and the spirit behind federation. But I think the sentiments expressed would fit Father Carr very well.]
- Letter from Father F. Forster to Father Carr, Aug.8, 1929, 5p., typewritten. [*Criticizing the "daring and even rash conception" behind the philosophy course at St. Michael's as getting away from the traditional and canonically required two-year course in scholastic philosophy.*]
- Reply from Father Carr, Aug.14, 1929 [*indicating that the course in scholastic had not been curtailed, and that they were doing what they could at St. Michael's to make the course fit the requirements of canon law.*]

It is in that capacity that I am speaking to you this evening." Using some of the materials fused in the previous letter, he proposes that almost all the priests on the SMC staff would be teaching philosophy, basing this teaching on the works of St Thomas.]*

Course Lecture Notes (CLN)

This section contains the largest and most important part of the papers. The "course lecture notes" are ITE's 'scripts' for classroom lectures. They are generally quite well polished and differ from an essay only in being more discursive and pedagogical. ITE himself organized his lecture notes in the late 1940s, binding them into numbered folders that he called "cahiers." Unfortunately, he seems not to have bound the notes after about 1950, and even some of the series before that date escaped the organizational system. The language of the notes is English except as otherwise noted.

Etienne Gilson was a professor of philosophy at universities in France and an internationally renowned scholar by the time he lectured at St. Michael's College in 1927. He was the founder (1929), along with the Basilian Fathers, of the Pontifical Institute of Mediaeval Studies for graduate work in philosophy. He held the position of Director from 1929 to 1978. The Gilson fonds includes his correspondence (personal and professional) on philosophical matters, and social problems in the light of his expertise in Thomistic philosophy. His articles and lectures on social and political subjects are recorded from his time at St. Michael's and PIMS.

Father Shook left in the file at this point a letter (now photocopied here) from Willard Hill to Mrs Michener on behalf of JM, 13 January 1962, mentioning Maritain's illness at the time. There was also here another letter, now present as a photocopy, from Gilson to Pegis, July 4, 1962, describing a chance meeting with JM having dinner in the Hotel Lutetia the previous night. He thinks JM will be found to have been "a man of action in the order of the intellectual life".

A further letter in the file at this point is that from Henri Bars to EG, 3 January 1963, discussing Gilson's critiques of his book on Maritain; Fr Shook's interest was in the matter of Bergson's "conversion". (Cf. JM above, 22 June 1960.)

Fr Shook has also in the file at this point the fragment of the letter from JM to Fréreric Lefèvre, 3 January 1925, given to Gilson by Henri Massis in February 1964.
