#### **Biographical Note:**

Herman B. Eisner (1875-1955) was founder and head of the H.B Eisner & Co., a general insurance agency in Scranton, Pennsylvania. He had six children including Major Joseph H. Eisner, who died in service. A Yeshiva in Scranton — the Milton Eisner Yeshiva High School — is named after him.

Agudas Israel (also known as Agudat[h] Israel, Agudas Yisroel, and the Aguda[h], translated as Union of Israel) is a movement, organization and political party founded in 1912 in Kattowitz, German Empire, by Orthodox Jews who opposed secularism and the Zionist movement. A branch of this movement was established in most countries in Eastern and Western Europe, as well as in British Mandate Palestine, and the Unites States. Although the organization opposed Zionism it did not object to Jewish settlement in Palestine. The organization began to purchase land in Palestine in the 1920's, and Israel became one of the centers for the movement after World War II. Agudat Israel continues to function as a political party in Israel, winning seats in the Knesset (Israeli parliament) with the party United Torah Judaism.

#### **Historical Context:**

In 1925 Herman B. Eisner purchased 1200 dunams (hectares) of land in the Machne Israel Colony in Emek Israel, Palestine, for thirty-seven thousand dollars from the Palastina-Centrale der Agudas Jisroel in Frankfurt-am-Main, Germany, but never received any Kushans (land registry certificates or deeds) to the property. Although the land was owned by Agudath Israel Jerusalem, the Frankfurt branch sold parts of the land to different people and only issued them unofficial certificates. Agudath Israel cited technical and economic difficulties as preventing them from producing Kushans for their buyers. Eisner retained a lawyer and contacted high-ranking officials and Rabbis to secure their support. After a lengthy land claim dispute the issue was settled in favor of Eisner.

#### **Scope and Content:**

Collection consists largely of correspondence between Herman B. Eisner, Agudath Israel representatives, various lawyers and Rabbis, and his family. Includes correspondence with Dr. Shlomo Ehrmann at the Frankfurt Agudas from whom Eisner purchased the land. Also includes correspondence between Eisner and attorneys M. Eliash and Dr. Mordecai A. Buxbaum, and other Agudath leaders including Rabbi Moshe Blau, head of Central Agudath Israel of Eretz Yisrael, and Mr. Jacob Rosenheim, head of Agudas Israel World Organization. Also includes correspondence with dignitaries including Democratic Whip Patrick J. Boland, the American Consul General in Palestine, the American Consul General in Frankfurtam-main, and Rabbi Yitzchok Herzog Chief Rabbi of Israel, among others. Also includes a small amount of correspondence authored by H.B. Eisner's son, Irving Eisner, and personal correspondence between H.B. Eisner and his wife and children during his trip in 1935 to Palestine.
