## FONDS-LEVEL DESCRIPTION

### Administrative history

The United Fruit Company (1899-1970) was an American corporation formed on 30 March 1899 as a result of a merger of the Boston Fruit Company (1885-1899) headed by Andrew Preston and Lorenzo Dow Baker, and the Costa Rican, Panamanian and Colombian railroad and plantation holdings of American railroad financier Minor C. Keith's Tropical Trading & Transport Company.

Headquartered in Boston, Massachusetts, Andrew Preston served as the company's first president until his death in 1924. In 1930, the United Fruit Company acquired Cuyamel Fruit Company, a competitor company headed by Samuel Zemurray. Zemurray went on to become managing director in charge of operations, then president of the company from 1938 to 1951.

By the mid-1900s, the United Fruit Company controlled (owned or leased) property made available to them by governments in multiple Caribbean and Central and South American countries including in Costa Rica, Colombia, Cuba, Guatemala, Honduras, Jamaica and Panama. The company imported products grown on plantations in Latin America (primarily bananas but also sugar, cocoa and other tropical products) transporting them to sell in North American and European markets.

Thomas E. Sunderland served as company president from 1960-1968. In 1970, the United Fruit Company merged with Eli Black's AMK Corporation, renaming this new entity the United Brands Company (1970-1989). Following the suicide and bribery scandal involving Black and company operations in Honduras, the company rebranded itself as Chiquita Brands International in 1990.

The Chiriqui Land Company was a United Fruit Company subsidiary, operating plantations in the Sixaola District in Costa Rica and the Bocas del Toro and Armuelles divisions in Panama.

**Dates of creation:** 1912-2004, predominant 1918-1970

**Physical description:** 52 cm of textual records (4 boxes)

7 photographs: b&w; 19 x 24 cm or smaller

4 maps: 55 x 91 cm or smaller

**Custodial history:** Material in this fonds consists primarily of corporate records created and/or received by the Chiriqui Land Company, a United Fruit Company (UFC) subsidiary that spanned the borders of Costa Rica and Panama. UFC central headquarters in the United States of America had ordered the material to be destroyed but had been retained in an attic of a semi-abandoned warehouse of the Costa Rican Chiriqui Land Company plantation. In the early 1980s when Philippe Bourgois was doing his fieldwork, the warehouse manager gave Bourgois permission to take whatever documents he wanted back with him to the United States. In May 2019, the material was sold and transferred to the University of Toronto Mississauga Library.

**Immediate source of acquisition:** Purchased from P. Bourgois, 2019.

**Scope and content:** Fonds contains primarily corporate records created, received, or used by management within the Chiriqui Land Company. Records include correspondence, memoranda, monthly production statistics and financial reports, personnel records, annotated newspaper clippings, some maps and photographs. The fonds consists of the following series:

**Accruals:** No further accruals expected.

**Arrangement:** The original order of the records as they were maintained by the Chiriqui Land Company is unknown as this current fonds consists of only the portion that Philippe Bourgois selected from the original archive. He organized this selection into file folders, labelled and arranged them thematically in the 1980s for the purposes of his doctoral thesis and the resulting monograph *Ethnicity at Work: Divided Labor on a Central American Banana Plantation*. The themes are:

- Development of monopoly power relationships with host-country governments
- Organization of ethnic-specific strategies to increase labour control
- Repression of labor discontent and labor-union organizing

Portions of the material were subsequently copied, some originals interfiled with copies, lent out, extracted then re-filed with other material, and otherwise rearranged over the years. Bourgois' 'original order' has been retained when both discernable and meaningful, but otherwise arranged by the archivist.

## SERIES-LEVEL DESCRIPTIONS

### SERIES 1: GOVERNMENT RELATIONS

**Dates of creation:** 1913-1966

**Physical description:** 7 cm of textual records

**Scope and content:** Series consists of correspondence and some reports documenting the relationship between the United Fruit Company and various levels of government in Panama and Costa Rica. These include internal company correspondence about dealings with the government as well as direct correspondence with government officials of varying ranks including presidents of the republics. Documents in this series reveal the extent of company influence vis-à-vis the governments and include correspondence related to export taxes, wages and nationality of workers, and appointment of key government officials. Another predominant subject is land appropriation and use especially around the Talamanca Valley and Sixaola River in Costa Rica, including the topic of squatters and the Bribri, the original and Indigenous inhabitants of this Costa Rican portion of the United Fruit Company's Bocas del Toro Division.

**Related groups of records:** See Series 6: Non-thematic Groupings and Series 9: Chronologically Organized Letters which include other documents that touch upon the same topics, and often include the originating letter or replies to letters found in this series.

**Arrangement:** Individual documents were placed into files by Bourgois and arranged chronologically by the archivist. Files were grouped into this thematic series by the archivist based on file title assigned by Bourgois.

**SERIES 2: LABOUR & ETHNICITY**

**Dates of creation:** 1921-1963

**Physical description:** 5 cm of textual records

**Scope and content:** Series consists primarily of material documenting the United Fruit Company's employment of specific national and/or ethnic groups of workers, including Panamanian, Ngäbe, Kuna, Bribri and Jamaican workers. It includes material related to negotiations between Panamanian government officials regarding quotas on Panamanian workers, and material documenting the employment of laborers from Indigenous groups in Panama and Costa Rica. Of especial significance are the multiple letters between the company and Kuna leader, Cacique Olotebiquina, as are a number of other letters that document efforts among the Ngäbe to organize their workers. Records include correspondence, reports, newspaper clippings and personnel lists.

**Related groups of records:** See Series 6: Non-thematic Groupings and Series 9: Chronologically Organized Letters which includes other documents that touch upon the same topics, and often include the originating letter or replies to letters found in this series.

**Arrangement:** Individual documents were placed into files by Bourgois and arranged chronologically within the files by the archivist. Files were grouped into this thematic series by the archivist based on file title assigned by Bourgois.

**Notes:** Some file titles and documents within this series contain outdated terminology to refer to peoples indigenous to the land on which the United Fruit Company operated. The Ngäbe are referred to as Guyami, Guaymi, Crimacola Indians or Ngöbe, and the Kuna are sometimes referred to as the Cuna or San Blas Indians.

**SERIES 3: LABOUR SUPPLY & CONDITIONS**

**Dates of creation:** 1919-1970

**Physical description:** 4 cm of textual records

**Scope and content:** Series consists of material generally related to labor supply and conditions on United Fruit Company plantations in Panama and Costa Rica. Topics covered include labor shortages, after hours entertainment for workers, medical coverage, wages and lawsuits against the company. Records include correspondence, memoranda and newspaper clippings.

**Related groups of records:** See Series 6: Non-thematic Groupings and Series 9: Chronologically Organized Letters which includes other documents that touch upon the same topics, and often include the originating letter or replies to letters found in this series.

**Arrangement:** Individual documents were placed into files by Bourgois and arranged chronologically within the files by the archivist. Files were grouped into this thematic series by the archivist based on file title assigned by Bourgois.

**SERIES 4: LABOUR ORGANIZING**

**Dates of creation:** 1918-1961

**Physical description:** 4 cm of textual records

**Scope and content:** Series consists of material related to the United Fruit Company's relationship to labour organizing and unions on their Costa Rican and Panamanian plantations, documenting the ways the company tracked and monitored labour organizing activity among their workers. In particular, the series includes records related to the strikes that took place in 1918, 1940s, 1950s, and 1960s, including correspondence and lists that name individual labor 'agitators' and workers deported as a result of participation in strikes. Also included are letters from or about Serafino Romualdi (1900-1967), Latin American representative of the American Federation of Labor (AFL) and Assistant Secretary of the Inter-American Regional Organization of Workers (ORIT). Records include correspondence, lists, and newspaper clippings.

**Related groups of records:** See Series 6: Non-thematic Groupings and Series 9: Chronologically Organized Letters which includes other documents that touch upon the same topics, and often include the originating letter or replies to letters found in this series.

**Arrangement:** Individual documents were placed into files by Bourgois and arranged chronologically within the files by the archivist. Files were grouped into this thematic series by the archivist based on file title assigned by Bourgois.

**SERIES 5: MARCUS GARVEY**

**Dates of creation:** [19--]-1927

**Physical description:** 1 cm of textual records

**Scope and content:** Series consists of material documenting the United Fruit Company's evolving relationship with Marcus Mosiah Garvey Jr. (1887-1940), a Jamaican-born Black nationalist and founder of the Universal Negro Improvement Association (UNIA). Letters include detailed reports of Garvey's activities while in Panama/Costa Rica and document the UFC's eventual cooperation and support of his visit. It also includes records related to groups he was associated with, including the Negro World and the Negro Improvement Association. Records include internal UFC correspondence, a telegram from Marcus Garvey, and a blank Universal Negro Improvement Association and African Communities League certificate.

**Related groups of records:** See Series 6: Non-Thematic Groupings, which include some other letters related to Marcus Garvey.

**Arrangement:** Documents were grouped together by Bourgois, and labelled and arranged chronologically within the series by the archivist.

**SERIES 6: NON-THEMATIC GROUPINGS**

**Dates of creation:** 1914-1970, 2004

**Physical description:** 7 cm of textual records and 2 photographs

**Scope and content:** Series consists of records organized into groupings by the last custodian (Bourgois), but do not appear to belong to any one thematic grouping. Material in the first half of the series appear to have been submitted for consideration to be published as part of Bourgois' 2003 article "One Hundred Years of United Fruit Company Letters." As such, individual records within this series serve as especially important representative samples of all the themes found in the other series. Of particular significance are letters and photographs identifying and targeting specific labor agitators; and internal correspondence discussing Marcus Garvey and Henrietta Vinton Davis, the first female president of the Universal Negro Improvement Association. Records include correspondence, two photographs, and a report produced by the Inter-American Regional Organization of Workers (ORIT).

**Arrangement:** The order of items as imposed by Bourgois has been maintained, though the material has been divided into file folders for preservation purposes.

**SERIES 7: INTERDIVISION VISITS & REPORTS**

**Dates of creation:** 1921-1931

**Physical description:** 4 cm of textual records

**Scope and content:** Series consists of correspondence, reports, telegrams and an official memorandum related to a somewhat formal program of exchange visits between North American managers of various tropical divisions of the United Fruit Company. Material documents the impetus and start of these interdivision visits, as well as correspondence discussing logistical arrangements and final reports for the visits. Records in the series provide insight into the lifestyles and working life of North American employees of the United Fruit Company in the 1920s, and reference a number of the steamships owned and operated by the company.

**Arrangement:** Original file titles have been retained, but records within the files have been arranged chronologically by the archivist.

**SERIES 8: STATISTICS & REPORTS**

**Dates of creation:** 1918-1984

**Physical description:** 9 cm of textual records

**Scope and content:** Series primarily consists of financial, production, personnel and other business records, including a series of monthly statements from the early 1930s and company statistical records from the 1980s. Also included amongst these business records are two seemingly unrelated letters, including a handwritten letter to the company from a destitute worker requesting a plot of land to live on. Records include reports, correspondence, memoranda and translated newspaper articles.

**Arrangement:** Files were grouped into this thematic series by the archivist based on file titles assigned by Bourgois. The order of documents within files as imposed by Bourgois have been retained, though they have been divided into file folders for preservation purposes.

**Dates of creation:** 1912-1971

**Physical description:** 13 cm of textual records

**Scope and content:** Series consists primarily of correspondence, but also newspaper clippings, newsletters, personnel and other lists, a poster and original and translated court orders and laws. Material in this series complements material found in thematically organized Series 1-6, as the originating letter or replies to letters found in this series can sometimes be found within the above series. As such, the records touch upon a wide variety of subjects including negotiations between company and government officials regarding labor quotas and export taxes; interactions between the company, labor unions, and workers of various ethnic backgrounds; and land appropriation and use.

**Arrangement:** No original order could be discerned. Material in this series was therefore organized into files by decade of creation, and arranged chronologically within the files by the archivist.

Series also includes five photographs which appear to be reprints of publicity photographs acquired from the United Brands Company Headquarters in New York in the 1980s. Photographs include depictions of United Fruit Company plantations, including in Guatemala.
