Scope and content: This accession largely consists of records related to *Ross MacKay, Saga of a Brilliant Criminal Lawyer: And his Big Losses and Bigger Wins in Court and in Life* by Jack Batten, including research, interview notes, manuscripts, newspaper clippings, materials related to MacKay's legal career, photographs, correspondence, and records from MacKay's family and childhood. The accession also includes research for and drafts of an unpublished memoir of philanthropist Jim Fleck, ghost written by Batten. The fonds also includes records pertaining to the 'Crang' novel *Booking In*, and Batten's Whodunit columns for *The Toronto Star*.

Scope and content: Series contains research materials and manuscripts drafts of a non-fiction book Batten wrote on Canadian criminal defense lawyer Ross MacKay. MacKay was defense counsel for the last two men to be executed in Canada in 1962, Arthur Lucas and Ronald Turpin. Batten's research covers MacKay's parents and childhood, and various stages of his career up to his death in 1983. Series includes: interviews with MacKay's friends, family, and colleagues; WP and holograph research notes; newspaper clippings; criminal case summaries and trial transcripts; photographs and negatives; correspondence; elementary and high school progress reports; and other textual records.

Arrangement: Oversize materials such as trial transcripts, bound manuscripts, and notebooks are physically stored in box 4, though they are intellectually organized with relevant materials in Series 1.
